Waco Housing Authority & Affiliates will be accepting applications on-line only for its Housing Choice Voucher Section 8 Waiting List for 9 hours on Thursday, July 20, 2017, beginning at 8:30 am and closing at 5:30 pm.

Applications must be submitted on-line at <a href="www.wacopha.org">www.wacopha.org</a> only during the time period that the waiting list is open.

Selection from the waiting list will be computer generated and will be determined by established preferences and date and time of application.

The Housing Choice Voucher Section 8 Assistance Program helps very low-income households with rent payments. To qualify, annual gross household income cannot exceed those listed below:
